Besides these research grants awarded, I received a project contract from Government of Luxemburg to support NCDs control in Shandong Province, China while I was working at WHO China Office. The project was implemented in eight counties between 2007-2009. The value of the project was €1.4 million. At TDR/WHO, my team developed a partnership with European Commission to promote stewardship in NTD (neglected tropical diseases) research. EC provided TDR with €2 million to support the initiative.
